

SUBSCRIBER AGREEMENT

To Comply with Rules 5(2), 8(3) and 11(2) of the Credit Reporting Privacy Code 2004 (CRPC). For a full copy of the Credit Reporting Privacy Code 2004 click [here](#)

1. **I state** that I am a New Zealand citizen, or am permanently resident in New Zealand, or am physically in New Zealand;
2. **I know** I must have my own TINZ user account and not use a generic “company/partnership/trust” user account.
3. **I know** I must inform the individual of the purposes for which I am collecting the individual’s personal information and the purposes for which the information will be used and disclosed to Tenancy Information New Zealand Ltd (TINZ) via the website at www.tinz.net.nz.
4. **I know** I must not disclose information to TINZ without taking such steps as are, in the circumstances, reasonable to ensure that the information is accurate, up to date, complete, relevant, and not misleading.
5. **I know** I must, as soon as reasonably practicable, update any credit default information, rating, 14 day notice, or serious credit infringement information previously disclosed to TINZ and ensure that the information remains accurate, up to date, complete, relevant, and not misleading.
6. **I understand** I will be asked to nominate the relevant purpose or purposes for which access (i.e. search or lodgement) may be sought, and confirm the relevant purpose at the time of each access.
7. **I know** I must co-operate with all reasonable compliance checks conducted by TINZ and, for that purpose, must supply, upon request, evidence to confirm compliance with the requirements of rule 11 or evidence to substantiate any credit default information, rating or 14 day notice or other serious credit infringement information disclosed to TINZ by me.
8. **I know** I must promptly cooperate with TINZ in its efforts to investigate and resolve complaints and requests for correction of credit information and must, for those purposes, supply, upon request, evidence to confirm compliance with the requirements of rule 11 of the CRPC or evidence to substantiate any credit default information or serious credit infringement information disclosed to TINZ by me.
9. **I know** I must take appropriate measures to safeguard the credit information held by TINZ against improper access.
10. **I agree** to indemnify and hold harmless T.I.N.Z. and its directors and officers, from any claim, suit, loss, damage or expense incurred by T.I.N.Z. and its directors and officers as a result of any references provided by me, use of a reference by me, or a my usage of the TINZ website.
11. **I know** if I am found breaching site rules I may have my membership suspended.
12. **I agree** to pay for the costs in using the T.I.N.Z. system on or before the 20th of the month following when I was charged.
13. **I acknowledge** that any cost incurred in collecting any unpaid invoices issued to me by T.I.N.Z. will be reimbursed by me. These may include collection agency charges and commissions, solicitor costs incurred and any cost that maybe incurred in recovering money from me.
